AGREEMENT NO. D005386 WITH THE STATE OF NEW YORK
DEPARTMENT OF TRANSPORTATION FOR THE FIXED LUMP SUM
MUNICIPAL SNOW AND ICE AGREEMENT TO EXPIRE ON JUNE 30, 2013.

Title of Resolution: A resolution for the Town of Clayton to extend into agreement No. D005386, with the State of New York Department of Transportation, for the fixed lump sum Municipal Snow and Ice Agreement to expire on June 30, 2013.

At a regular meeting of the Town Board of the Town of Clayton, Jefferson County, New York, held at the Town Hall, Clayton, New York, on the 12th day of December, 2012, at 5:00 PM prevailing time:

WHEREAS, the Town of Clayton has received a letter from Dennis Pawlicki, Regional Director, State of New York Department of Transportation, dated December, 2012, and

WHEREAS, the letter is in reference to extending the Fixed Lump Sum Municipal Snow and Ice Agreement for the period 2013-2014, which was extended until June 30th, 2013, and

WHEREAS, the agreement is recalculated to be \$4,833.68 per lane mile for 12.0 lane miles for a total of \$58,004.17 for the 2011-2012 season and for the remainder of the term of the agreement commencing July 1, 2011, unless changed by future update.

NOW, THEREFORE, BE IT RESOLVED, that the Town of Clayton Town Board authorizes the Town Supervisor to sign the Extended Fixed Lump Sum Municipal Snow and Ice Agreement that will expire on June 30, 2013.
