A RESOLUTION FOR THE TOWN OF CLAYTON TO EXTEND INTO AGREEMENT NO. D005386 WITH THE STATE OF NEW YORK DEPARTMENT OF TRANSPORTATION FOR THE FIXED LUMP SUM MUNICIPAL SNOW AND ICE AGREEMENT TO EXPIRE ON JUNE 30, 2016.

Title of Resolution: A resolution for the Town of Clayton to extend into agreement No. D005386 with the State of New York Department of Transportation for the Fixed Lump Sum Municipal Snow and Ice Agreement to Expire on June 30, 2016.

WHEREAS, the Town of Clayton has received a letter from Steve Kokkoris, Regional Director, State of New York Department of Transportation, dated, January 22nd, 2015, and

WHEREAS, the letter is in reference to extending the Fixed Lump Sum Municipal Snow and Ice Agreement for the period 2016-2017, which is extended until June 30th, 2017, and

WHEREAS, the agreement is recalculated to be \$4,833.68 per lane mile for 12.0 lane miles for a total of \$58,004.17 for the 2014/15 Extension Year and for the remainder of the term of the agreement commencing on July 1, 2014, unless changed by future update.

IN WITNESS WHEREOF, BE IT RESOLVED, that the Town of Clayton Board authorizes the Town Supervisor to sign the Extended Fixed Lump Sum Municipal Snow and Ice Agreement that will expire on June 30, 2016.
