A RESOLUTION TO INQUIRE OF THE JEFFERSON COUNTY HIGHWAY SUPERINTENDENT AND THE NEW YORK STATE DEPARTMENT OF TRANSPORTATION TO CHECK AND REDUCE SPEED ON THE GREENIZEN ROAD, TOWN OF CLAYTON.

TITLE: A resolution to inquire of the Jefferson County Highway Superintendent and the New York State Department of Transportation to check and reduce speed on the Greenizen Road, Town of Clayton.

At a regular meeting of the Town Board of the Town of Clayton, Jefferson County, New York, held at the town offices, 405 Riverside Drive, Clayton, on the 27th day of May, 2015, at 5:00 PM prevailing time:

The following resolution was offered by Mary Zovistoski, who moved its adoption, seconded by Lance Peterson, to wit:

WHEREAS, the Town of Clayton has been approached by residents on the Greenizen Road, Town of Clayton, requesting that the speed limit on the Greenizen Road be lowered from 55 MPH down to a 40 MPH maximum, due to the increase of traffic at high rates of speed in this populated residential area, as they feel this would make their roads safer for other vehicle traffic, pedestrians and many children at play, therefore

BE IT RESOLVED, that the Town Board passed this resolution requesting the Jefferson County Highway Superintendent and the New York State Department of Transportation evaluate this section of Greenizen Road, Town of Clayton for reduction from the current 55 mph to a maximum 40 mph for the safety of the residents of this area.

THEREFORE, BE IT RESOLVED, that this resolution be sent to the Jefferson County Highway Superintendent, for his review and forwarding to the New York State Department of Transportation for their review.
