

**RESOLUTION #49 OF 2014
TOWN OF CLAYTON
A RESOLUTION TO INSTRUCT THE ASSESSOR OF THE TOWN OF CLAYTON TO
REVIEW ALL ASSESSMENTS FOR THE 2015 ASSESSMENT ROLL IN ACCORDANCE
WITH THE NEW YORK STATE REAL PROPERTY TAX LAW.

Title of Resolution: A resolution to instruct the Assessor of the Town of Clayton to review all assessments for the 2015 Assessment Roll in accordance with the New York State Real Property Tax Law.

At a regular meeting of the Town Board of the Town of Clayton, Jefferson County, New York, held at the Town Offices, on the 10th day of September, 2014, at 5:00 PM prevailing time:

The following resolution was offered by Robert W. Cantwell III, who moved its adoption, seconded by Lance Peterson to wit:

WHEREAS, the Town Board of the Town of Clayton wishes to be in compliance with the NYS Real Property Tax Law, Section 305, by assessing all real property at a uniform percentage of full value (100%), and

WHEREAS, the Town of Clayton has signed with the NYS Real Property Tax Division and has partnered with another Municipality to keep the assessments at 100%, and

WHEREAS, the NYS Real Property is offering an incentive with a reimbursement of up to \$5/parcel to review and keep the uniform percentage at full value (100%), therefore

BE IT RESOLVED, the Town Board of the Town of Clayton is hereby instructing the Assessor of the Town of Clayton to review all assessments for the 2015 Assessment Roll in accordance with the New York State Real Property Tax Law to qualify for a reimbursement of up to \$5/parcel.
