

**RESOLUTION #51 OF 2014
TOWN OF CLAYTON
A RESOLUTION TO MODIFY THE BILLING PROCESS FOR THE DEPAUVILLE SEWER DISTRICT.
SEPTEMBER 10, 2014**

Title: A resolution to modify the billing process for the Depauville Sewer District.

At a regular meeting of the Town Board of the Town of Clayton, Jefferson County, New York, held in the Town Board Room at 405 Riverside Drive, Clayton, New York, on the 10th day of September, 2014 at 5:00 PM prevailing time:

The meeting was called to order by Supervisor Taylor and upon roll being called, the following were:

The following resolution was offered by Robert W. Cantwell III, who moved its adoption, seconded by Mary Zovistoski, to wit:

WHEREAS, the Town of Clayton Depauville Sewer District residents since its inception have paid the bills quarterly and in the arrears, and

WHEREAS, the payment of said quarterly bills has necessitated quarterly mailings of said billings, and

WHEREAS, with the continued rising cost associated with said mailings, and

WHEREAS, Town Board of the Town of Clayton has met with the Depauville Sewer Advisory Board on several occasions and expressed the interest of stream lining both manual labor and rising costs associated with the billings, and also took public comments from Depauville residents at our town meeting in Depauville on August 28th, 2014, and

WHEREAS, the Town of Clayton Town Board, wishes to have all Sewer Districts within its township pay their sewer bills in a like manner,

NOW, THEREFORE, BE IT RESOLVED, THAT THE Town Board has determined that the Depauville Sewer District should now be modified and payment(s) will, starting with January 1st, 2015, be applied to the tax parcel owners of record Town & County Tax bills, so that payment will after two years be solely paid by Levy Line on the Town & County Tax Bill(s), for that current fiscal year in advance.
