A Local Law to Establish a Moratorium on Applications For The Review and Approval of Permits for Wind Energy Facilities within the Town of Clayton

Be it enacted by the Town Board of the Town of Clayton as follows:

#### Section 1.

There is hereby established a moratorium on applications for the review and approval of permits for Wind Energy Facilities as that term is defined in Town of Clayton Local Law #1 of 2011 as amended, within the Town of Clayton. During the moratorium period, no applications for the review and/or approval for the siting, construction or placement of Wind Energy Facilities within the Town of Clayton shall be accepted and no review of proposed Wind Energy Facilities shall be conducted or continued, and no final determination in connection therewith shall be made by the Planning Board, and no permits therefor shall be issued.

### Section 2.

The period of the moratorium established by this Local Law shall be six (6) months from the effective date of this Local Law.

#### Section 3.

This Local Law shall take effect upon the filing with the Secretary of State as required by the Municipal Home Rule Law.
