### (NOT INCLUDING ELECTRICAL INSPECTIONS)

Residential one- and two-family homes will be charged a fee of \$ .50 per square foot.

Auxiliary structures will be charged a fee of \$ .35 per square foot or a minimum of \$50.00.

**All renovations, commercial construction and non-residential projects will be charged with the following rate scale. Permit Fee is based on proposed cost for construction.**

Up to \$500	No Charge
\$501 to \$2,000	\$35.00
\$2001 to \$25,000	\$35 for first \$2,000 + \$4.65 for each additional \$1,000 or fraction thereof
\$25,001 to \$100,000	\$142 for first \$25,000 + \$2.10 for each additional \$1,000 or fraction thereof
\$100,001 to \$250,000	\$300 for first \$100,000 + \$2.20 for each additional \$1,000 or fraction thereof
\$250,001 to \$500,000	\$630 for first \$250,000 + \$2.30 for each additional \$1,000 or fraction thereof
\$500,001 to \$1,000,000	\$1,205 for first \$500,000 + \$2.40 for each additional \$1,000 or fraction thereof
\$1,000,001 to \$5,000,000	\$2,405 for first \$1,000,000 + \$2.50 for each additional \$1,000 or fraction thereof
Over \$5,000,001	\$12,405 for first \$5,000,000 + \$2.60 for each additional \$5,000 or fraction thereof

## **ADD CERTIFICATE OF OCCUPANCY TO ALL PERMITS**

All Temporary Certificates are valid a maximum of 90 days from date of issuance.

In the event that a building permit must be renewed, a fee of not less than \$25.00 nor more than 50 percent (excluding permit fees under \$50.00) of the original permit will be charged prior to re-issuance of the permit.

Any inspections requested outside of normal business hours will be billed at the rate of \$25.00/hr. (2 hrs. minimum charge) in addition to regular permit fee.

Island inspections will be charged a fee of \$75 per inspection to cover the cost of a boat and captain, unless acceptable transportation is provided.

The Town & Village require two hard copies of plans and specs. If not provided an additional fee will be charged per page to have scanned and converted.

Fees are:

1-20 \$2.95 each

21-99 \$1.95 each

100 + \$1.45 each
